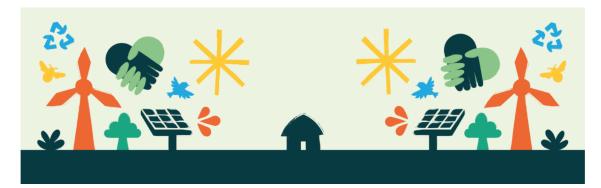

This year, the UK will be playing host to COP26- the annual UN climate change conference that will 'make or break' the strength of global climate agreements

for decades to come.

COP26 will be the biggest ever diplomatic conference the UK has ever hosted, and Parliament, devolved administrations and local councils alike will be working to demonstrate that they are committed to raising the ambition of their climate commitments.

As a member of the largest women's voluntary organisation in the UK, there will be a range of opportunities for you to raise your voice and show your support for COP26 agreements that deliver ambitious and fair climate action fit for the 21st century and beyond.

Rural England (where the WI is a stakeholder) has launched a survey as part of work on its *State of Rural Services 2021* report, aimed at rural residents. The survey asks about use of services since the start of Covid-19 restrictions, and how you expect to use those services in future.

The survey is open to rural residents in England and should take around 10 to 15 minutes to complete. It will close on 4th June.
