### **Resolution Shortlist Selection Resources**

In the November/December issue of WI Life which landed with members last week, you will find information about the five shortlisted resolutions for 2021/2022 which will now be taken forward for further debate and voting by members!

The shortlisted resolutions are:


- 1. Fit for Purpose Fit for Girls
- 2. Appropriate Sentencing of Non-Violent Women Offenders
- 3. Equality in Law for the Menopause
- 4. Women and Girls with ASD and ADHD Under-Identified, Under-Diagnosed and Under-Supported
- 5. Tackling Digital Exclusion

What happens now?

Every member now has the opportunity to cast their individual selection on the resolution they support the most. WIs are encouraged to hold meetings to provide members with the opportunity to discuss and learn more about each resolution. However, if this is not possible members can research the issues themselves and make their selection.

The deadline for members' selections to reach their federations is 14 February 2022.

## Stop Modern Slavery: Ask your MP for urgent changes to the Nationality and Borders Bill

More than 100 leaders in the human rights and anti-slavery sector have written to MPs asking for urgent changes to the new Nationality and Borders Bill currently making its way through Parliament.

The Bill could mean more victims of modern slavery going unidentified, including British victims and children, and make it harder to prosecute traffickers.

To make this message even louder, we need your help.

#### The NFWI at COP26- and where next?

Between the 1<sup>st</sup>- 13<sup>th</sup> November 2021, COP26 took place in Glasgow. The Chair of the NFWI Public Affairs Committee, Nicky Amos and members of the NFWI Public Affairs team attended the conference between the 4<sup>th</sup>- 7<sup>th</sup> November 2021.



On the 5<sup>th</sup> November, the WI had a stand in the UK Government's 'Green Zone.' This showcased the work of WI members and Climate Ambassadors throughout 2021 and in the run-up to COP26. The WI Climate Scrapbook was on display, in addition to a video produced by Cheshire Climate Ambassadors. Visitors to the stand were given a No More Loopholes bracelet made by WI members and made pledges which were tied onto the giant 'No More Loopholes' bracelet. We met visitors from across the world and showcased the WI to a new audience.

On the 6<sup>th</sup> November, the NFWI Public Affairs team battled the Scottish weather and marched alongside 100,000 people during the Glasgow Global Day of Action to demand climate justice and climate action that would keep us on track for 1.5C of temperature rises. WI members marched across the UK in London, Cardiff, Manchester and Birmingham- and that's just the places we know about!



COP26 was a vital staging post towards a net-zero world with 1.5C of temperature rises.

At Glasgow, we saw the world pick up the pace of climate action and turned the temperature gauge down. COP26 wasn't the complete solution, but the gap between where we are and a safer world is slowly but surely beginning to close.

But the NFWI are clear that COP26 should only be the start of the UK's climate ambitions. The UK still remains as the COP26 President until November 2022, and it must do all that it can to pressure other nations to continue to ratchet up their climate ambitions and put their pledges at CO2P6 into action. The UK has a start of a plan through its long term net-zero strategy, but there's still huge amount of work to be done from every member of the Government.

But the reason that progress has happened is because of pressure from WI members and the general public on the UK Government to push us towards a better, greener world.

Findings of an Ipsos MORI poll released last week showed the highest level of concern about climate change since the agency began polling in 1988. More and more, there is growing public awareness of the need for our leaders to take ambitious climate action fit for the 21<sup>st</sup> century.

Lots has been done, but there is still lots to do. Over the next few months, the WI will be keeping up the momentum on our climate change campaigning work. There will be lots of opportunities for you to take part in The Climate Coalition's campaign plans like February's Show the Love 2022 and the Great Big Green Week in September 2022, and plenty more on the WI's own environmental campaigns.



The WI supports the Microplastic Filters (Washing Machines) Bill

As part of the WI's work on our End Plastic Soup campaign, and as part of our work as the Secretariat to the All-Party Parliamentary Group on Microplastics, the WI is supporting Alberto Costa's 10 Minute Rule Bill to fit all new washing machines with a microplastic fibre capture filter and for there to be more public

education on the environmental effects of microplastic fibre release.

The Bill received its first reading on Tuesday 30 November and passed to its Second Reading. The Bill will next be discussed in Parliament on Friday 21 January 2022.

The WI co-hosted a parliamentary drop-in on 23 November where we spoke to MPs about the Bill and the need for all washing machines to be fitted with microplastic fibre capture filters. Over 20 MPs attended the drop-in, in part thanks to the efforts of WI members writing to their MP to ask them to attend the event.
