#### '500 CLUB'

- 1. The lottery will be known as 'The Norfolk Federation of WI's 500 Club' (hereinafter called '500 Club') and be registered at the Norfolk Federation office, Evelyn Suffield House, 45 All Saints Green, Norwich, NR1 3LY.
- 2. Participation in the Club is open to all Norfolk Federation of WI's members with the exception of members of the Board of Trustees and staff employed by the Federation.
- 3. The Club is formed for fund raising purposes and all proceeds raised by the Club, after provision of prizes, will be devoted to the Federation Funds.
- 4. Application for participation in the Club must be made to the Federation Secretary, the person authorised by the Federation Board of Trustees. The subscription will be £5.00 per share per annum, the year being 1 November to 31 October.
- 5. There will be a maximum of 500 shares, which can be held singly or in multiples. Every share must be registered in a single name.
- 6. Under the 1992 Charities Act shares cannot be held in the name of a WI.
- 7. All money is to be paid in full before the first draw is made.
- 8. Each participant will receive a copy of these Rules with the application form and with the registered number for each share held.
- 9. There will be draws for 50% of the capital deposit each year. Regular draws for the prizes will be arranged at the discretion of the Board of Trustees and held in the presence of at least five persons.
- 10. The list of prizewinners will be published monthly in the Norfolk WI News.
- 11. The decision of the Board of Trustees of the Federation is final in any matter requiring adjudication. The Board has the power to amend or revoke these Rules after 28 days' notice has been given to all members.
- 12. The promoter of the Club shall be the Secretary or Agent of the Federation.
